

Privacy Policy

1. Introduction

Moonlight Travel LLC (“Moonlight Travel,” “we,” “us,” or “our”) respects your privacy and is committed to protecting the personal information you share with us. This Privacy Policy explains how we collect, use, disclose, and safeguard your information when you visit our website or engage our travel services.

2. Information We Collect

3. How We Use Your Information

- Communicate with you about your travel arrangements
- Provide customer service and support
- Personalize your travel experience and service offerings
- Send booking confirmations, updates, and relevant marketing (if opted-in)
- Improve our website, services, and client communication processes
- Comply with applicable laws, regulations, and industry requirements

We will not sell or rent your personal information to third parties.

4. Sharing of Information

We may share your information with trusted third parties solely for purposes related to providing our travel services, including:
